## RENUNCIATION OF PHILIPPINE CITIZENSHIP

### REQUIREMENTS:

1. Applicant must at least be 18 years old.
2. **Affidavit of Renunciation of Philippine Citizenship**, Duly-notarized by a Notary Public. – One (1) original and two (2) photocopies
3. **Philippine Passport** – original passport will be cancelled and retained at the Philippine Consulate General. – Original and three (3) photocopies
4. **For those who have retained/re-acquired Philippine Citizenship (Dual Citizens) under R.A. 9225** – submit Identification Certificate, Oath of Allegiance, and Order of Approval – originals will be cancelled and retained at the Philippine Consulate General. – Originals and two (2) photocopies
5. **Birth Certificate** (PSA/NSO authenticated Certificate of Live Birth (COLB) / Report of Birth (ROB)). – Original and two (2) photocopies
6. U.S. Certificate of Naturalization / U.S. Passport / State Identification Card / Driver's License / other valid IDs. – Present original and three (3) photocopies
7. **For those born in U.S.A.** – submit proof of Philippine Citizenship of parent/s at the time of birth (e.g. US Naturalization Certificate, U.S. Green Card/ Permanent Resident Card, Philippine Passport). – Three (3) photocopies

### NOTE:

- a. Additional documentation may be required based on the documents presented and special circumstances of the applicant.
- b. Applications submitted through an agent or third party should include an Authorization Letter signed by the applicant.
- c. Applications submitted by mail must include a **(1)** Cover Letter with contact details (e.g. phone/mobile number, email address) of the applicant and a **(2)** Self-Addressed Stamped Return Envelope or Self-Addressed Prepaid Mailing Return Envelope.

**CERTIFICATION FEE: \$25.00** (non-refundable). Fees should be made payable to the "*Philippine Consulate General*" in Cash, Money Order, Bank Draft, Certified Check, or Cashier's Check. *Personal checks and credit/debit cards are not accepted.*
