RENUNCIATION OF PHILIPPINE CITIZENSHIP

REQUIREMENTS:

1. Applicant must at least be 18 years old
2. Affidavit of Renunciation of Philippine Citizenship notarized by a Notary Public - **original and two copies**
3. Philippine passport – original passport will be cancelled and retained at the Philippine Consulate General - **original and two copies**
4. For those who have retained/re-acquired Philippine citizenship (dual citizens) under R.A. 9225, submit Identification Certificate, Oath of Allegiance, and Order of Approval – originals will be cancelled and retained at the Philippine Consulate General - **original and two copies**
5. Birth certificate - **original and two copies**
6. US certificate of naturalization / US Passport / State ID / driver license - **two copies**
7. For those born in the United States of America submit proof of Philippine citizenship of parent/s at the time of birth (e.g. US naturalization certificate, US green card, Philippine passport) - **two copies**

NOTE:

Additional documentation may be required based on the documents presented and special circumstances of the applicant.

Applications submitted through an agent or third party should include an authorization letter signed by the applicant.

Applications submitted by mail must provide the contact details (e.g. phone/mobile number, e-mail address) of the applicant and a self-addressed stamped envelope.
